## Duties

The Deputy Director of the Office of Airport Safety and Standards assists the Director in leading the development of airport standards for safety, operations, and engineering. This includes analyzing airport and aviation safety data to determine trends and to develop and implement programs and Advisory Circulars to promulgate information to airports and the aviation community for airport design information, operating procedures, and equipment specifications.

The incumbent assists in the administration of the Airport Certification program under Part 139 of the Federal Aviation Regulations. He/she is also responsible for the implementation of Safety Management Systems at certain U.S. airports, establishing and ensuring the completion of safety goals for the annual FAA Strategic and Business Plans, and tracking progress throughout the year.

The Deputy Director shares the Director's responsibilities for leadership, direction, and performance of the Airport Safety and Operations Division, Airports Engineering Division, and the Airport Technology Research and Development Branch at the William J. Hughes Technical Center.

The incumbent provides program oversight of the Airport Technology Research Program including the initiation of research projects and approval of research plans and contract deliverables. He/she also provides management oversight of the Airport Cooperative Research Program including the contract support from the National Academy of Sciences. He/she represents the office on the FAA Research and Development Executive Board.

The incumbent provides program oversight for the Office of Airport's International Program. This includes developing an annual international support plan and budget that allows the office to effectively coordinate airport standards and safety issues with the International Civil Aviation Organization (ICAO), international airport associations, and the other FAA organizations. The incumbent represents the FAA and the office at high level international aviation and airport meetings to present FAA airport safety issues and new airport technology. He/she works with the FAA international Aviation office to coordinate and deliver airport technical assistance to improve airport safety in developing countries.

Strong interdisciplinary skills and experience in handling a large diverse workforce and management experience in the following is essential: budgeting, contract management, performance management, communications and business planning.
